ABOUT DIRECT DEBIT

All your bank information is kept confidential. QPSU will provide 14 days notice of any change in the terms of your arrangement. If you wish to cancel or change your arrangements please provide 14 days notice. Bank debits occur fortnightly on pay days. Credit card payments are processed on the 28th day of each month. Please ensure your nominated account can accept debits of this kind and there are enough funds to cover the payment. Your bank may charge you a dishonour fee if there is insufficient funds.
